

Privacy Policy

Your privacy is important to **PIBBLE PTE. LTD.** ("company", "us", "our", or "we"). We've created this privacy policy ("Privacy Policy") to cover:

1. Personal information you provide or we collect about you when you engage with company in connection with your purchase or attempted purchase of PIBBLE tokens (your "Purchase");
2. the purpose for which we use that information; and
3. how we share that information with third parties.

Personal information that you provide in connection with your use of the company platform will be governed by the Platform Terms and Policies.

Where referenced herein, "company" includes our affiliated companies and subsidiaries. This policy applies to information we collect in connection with your Purchase, including:

1. On this site, <https://pibble.io/> (the "Site"); and
2. In email, text, and other electronic messages between you and company relating to your Purchase.

By accessing or using this Site, you agree to this Privacy Policy. This policy may change from time to time. Your continued use of this Site after we make changes is deemed to be acceptance of those changes, so please check the Privacy Policy periodically for updates.

A company that decides how it uses personal information is called a Data Controller under the law of certain jurisdictions. When you provide Information to us, company is the Data Controller.

INFORMATION WE COLLECT

Information you give us. We collect some content and other information you provide when you Purchase PIBBLE tokens. The types of information we may collect include your name, email address, postal address, phone number, payment method data, birth date, and any other information you choose to provide. We may also ask you for additional government-issued identification or other information to validate your identity as required by our policies and procedures.

Information we get from your Purchase. When you use our Site, we automatically collect information about you, including:

1. **Log Information:** We collect log information about your use of the Site, including the type of browser you use, access times, pages viewed, your IP address, and the page you visited before visiting our Site.
2. **Device Information:** We collect information about the computer or mobile device you use to access our Site, including the hardware model, operating system and version, unique device identifiers, and mobile network information.
3. **Location Information:** We collect information about the location from where you Purchase PIBBLE tokens or access the Site.

4. Information Collected by Cookies and Other Tracking Technologies: We and our service providers collect information using various technologies, including cookies and pixel tags (which are also called clear GIFs, web beacons, or pixels). See our Cookie Policy for more information about our use of cookies.

The foregoing information, including information you provide and information we collect is referred to in this Privacy Policy as "Your Information".

We use Your Information to analyze trends, administer the Site and allow you to Purchase PIBBLE tokens, track users' movements around the Site and Services, gather demographic information about our user base as a whole, and better tailor our Site and Services to our users' needs.

Information collected by others. We may use third-party analytics companies and identity verification services ("Third Party Information"). Third Party Information may be used for purposes disclosed by the applicable third party in its privacy policy, and by us to allow you to Purchase PIBBLE tokens.

We may also combine Third Party Information with Your Information. When we do so, the Third Party Information is treated as Your Information.

HOW WE USE YOUR INFORMATION

- To enable your Purchase of PIBBLE tokens. We use Your Information to allow you to Purchase PIBBLE tokens.
- To communicate with you. We use Your Information to keep you posted on important announcements regarding the PIBBLE token sale.
- To promote safety and security. We may use Your Information, including date of birth, to verify identity and to determine your eligibility to Purchase PIBBLE tokens. We may also use Your Information for loss prevention, anti-fraud and/or unauthorized activity, to prevent and investigate potentially prohibited or illegal activities, and to enforce our Terms of Use.
- To fulfill and enforce our rights and obligations. We use Your Information to carry out our obligations and enforce our rights arising from any contracts entered into between you and us.
- For other uses. We may use Your Information in any other way we may describe when you provide Your Information, and for any other purpose with your consent.

We may also create anonymous, aggregated and/or other de-identified data records ("Anonymous Information") from Your Information by excluding specific data (such as your name) that makes Your Information personally identifiable to you. We use this Anonymous Information to analyze request and usage patterns so that we may enhance the content on our Site and to improve Site navigation. We reserve the right to use Anonymous Information for any purpose and to disclose such data to third parties in our discretion.

HOW WE SHARE INFORMATION

We do not share, sell or transfer Your Information without your consent, except as described below:

- Our service providers and/or financial institutions. We may provide Your Information to

our service providers and/or financial institutions with who we are working to help operate our Site and offer PIBBLE tokens for sale. Examples include suppliers that host our data or provide customer service. We require our service providers and/or financial institutions to use Your information only as needed to operate the Site or provide services that enable your Purchase of PIBBLE tokens.

- Our related companies. We may share some or all of Your Information with our related companies, including our affiliates, subsidiaries, or joint ventures who are also required to honor this Privacy Policy.

- To protect company and its users, or for legal purposes. We may disclose Your Information: (a) if we think it's needed to detect, prevent or address illegal activity with respect to your Purchase of PIBBLE tokens, or identify, contact or bring legal action against someone who appears to be causing injury to or interfering with our rights or property or other users; (b) as part of a company legal matter or investigation, including an investigation related to a suspected breach of our Terms of Use; (c) when we believe that disclosure is required or permitted by law, including when responding to subpoenas, warrants, production orders, or similar instruments; or (d) if we believe that disclosure is needed to prevent financial loss; protect your safety or the safety of others, including when there is an emergency involving potential harm, loss of security or serious injury to people or threats of such emergencies; or if we are obligated to report illegal activity.

- Audits. We may need to share Your Information in order to complete third party financial, technical and legal audits of our operations as part of that review.

- Merger, financing or sale. We may share, provide, or sell Your Information in connection with a merger, financing, acquisition, dissolution transaction, bankruptcy or proceeding involving sale, transfer, divestiture of all or a portion of our business or assets. If another company acquires our business or assets, that company will have Your Information collected by us and will assume the rights and obligations regarding Your Information as allowed by this Privacy Policy.

HOW WE RESPOND TO DO NOT TRACK SIGNALS

We do not currently respond to "do not track" signals or other mechanisms that might enable you to opt out of tracking on our Site.

THIRD PARTY WEBSITES

The Site may contain links to third party websites. When you click on a link to any other website or location, you will leave the Site and go to another site, and a third party may collect personal information or other information from you. We have no control over, do not review, and are not responsible or liable for, these third party websites or their content. Please be aware that the terms of this Privacy Policy do not apply to these third party websites or their content, or to any collection of your personal information after you click on links to any such third party websites. We encourage you to read the privacy policies of every website you visit. The links to third party websites or locations are provided merely as a convenience and do not signify or imply our endorsement of, or association with, such third parties or their products, services, content, or websites. You use any such links and the products, services, and content accessed thereby at your own discretion and at your own risk.

ACCESS TO INFORMATION

You can also request access, updating and corrections of inaccuracies in Your Information by emailing or writing to us at support@company.com. We may ask you for

certain information in order to verify your identity. If you request a copy of Your Information we may charge a small processing fee. If you ask us to correct any inaccuracies in Your Information there is no fee.

We seek to limit access to Your Information only to those employees who require such information to handle matters relating to compliance, identity verification and customer support.

RETENTION OF PERSONAL INFORMATION

We will retain Your Information for as long as necessary for the uses set out in this Policy. If you ask us to delete Your Information prior to that time, we may not be able to do so, due to technical, legal, regulatory or contractual constraints. If you ask for your account to be closed, we will do this as soon as is reasonably possible subject to any applicable terms and conditions relating to the account. Note that Your Information from closed accounts is retained in order to comply with legal obligations, prevent fraud, collect any fees owed or to resolve disputes.

DATA TRANSFERS

Our servers and our service providers may be located in the United States or other countries. As a result your data may be transferred from the country in which you provided it to us. Because of this, Your Information may be available to the U.S. government and its agencies, or other governments or their agencies under the laws of the applicable country. The laws of those countries may be less strict regarding Your Information than the laws of the country from which you provided Your Information or where you live.

A NOTE ABOUT CHILDREN

Children under the age of 18 are not eligible to Purchase PIBBLE tokens and must not attempt to register for the Site, Purchase PIBBLE tokens or submit any personal information to us. We do not knowingly collect personal information from anyone who is under the age of 18. If it comes to our attention that we have collected personal information from a child under 18 without verification of parental consent, we will attempt to delete this information as quickly as possible.
